2	No activity on ground shall be undertaken without obtaining Environmental Clearance from the Ministry of Environment and Forests, Government of India as per S. O. No.19(E), dated 06-01-2011.	Obtained CRZ clearance vide letter no F. No 11-62/2013-IA .II dated 27 <sup>th</sup> Aug, 2014 prior to undertaking of the job.
3	The industry shall follow the new standards as Pollution proposed by the Central Control Board (CPCB) under the Environment (Protection) Act, 1986.	Being followed the provisions of the Environment Protection Act Act 1986.
4	The industry shall undertake afforestation of lands along the coast using suitable local species to serve as shelter belt and wind breaks to ensure protection of interior areas.	Undertaken afforestation with available local species.
5	The proposed pipeline shall be aligned in the existing corridor earmarked for laying the pipelines from the Deep water Port, Kakinada.	Complied. The pipeline aligned in the corridor earmarked for laying the pipelines from the deep water port of Kakinada.
6	Phosphoric acid being hazardous chemical, there shall not be any Compromise on safety to vegetation and human beings. Adequate safety measures should be taken to avoid leakage.	Adequate safety measures are being taken.
7	The industry shall submit the detailed drawings of pipeline alignment along with location map to the scale, duly marking the path of the proposed pipeline in the CRZ map. Necessary details pertaining to excavation through various zones and other relevant information shall also be furnished for the purpose of record.	The detailed drawing and other information of the pipeline alignment submitted to the concerned authority.
8	All safety measures shall be incorporated to avoid any possible accidents. Adequate safely measures shall be taken to prevent leakage of waste water into surrounding areas.	Developed suitable safety measures and integrated with existing Onsite Emergency Plan and the same is being followed.
