3. The Ministry of Environment, Forest and Climate Change has examined the proposal seeking Transfer of Environmental clearance (EC) granted vide letter no. F. No. J- 11012/77/94-IA II dated 2nd March 1995 for Modernization cum Expansion of the DAP Plant to M/s Godavari Fertilisers and Chemicals Ltd. at Kakinada, Andhra Pradesh.

4. M/s Coromandel International Limited has applied for transfer of EC (Form 7) on PARIVESH portal to transfer the said EC from M/s Godavari Fertilisers and Chemicals Ltd. to M/s Coromandel International Limited.

5. PP informed that CTO is obtained vide letter no, APPCB/VSP/RJY/285/HO/CTO/2021 dated 07-03-2023 in name of M/s. Coromandel International Ltd; Validity of latest consent (valid up to) is till 30-09-2026. Further the Company name changed from M/s Godavari Fertilisers and Chemicals Ltd. to M/s Coromandel Fertilisers Ltd. in the year 2008. Later the name of the company changed from M/s Coromandel Fertilisers Ltd. to M/s Coromandel International Limited in the year 2009. As per the documents submitted on portal by PP, Godavari Fertilisers and Chemicals Limited (GFCL) was merged with M/s Coromandel Fertilisers Limited (CFL) pursuant to scheme of Amalgamation approved by Hon'ble High Court of Andhra Pradesh order dated 18.12.2007. Later name of the company was changed from M/s Coromandel Fertilisers Limited in order to reflect the varied businesses carried by the company and its business potential across the globe.

6. As per par 9 of the OM dated 3rd Nov 2023 IA3-22/19/2023-I.A. III [E 226246], PP was asked about the reason for not submitting the application for transfer of EC within a period of 24 months from the date of change in name of the company. PP vide ADS reply dated 20/8/2024 informed that, which is reproduced below:

"The environmental clearance was taken from MoEF&CC on 23rd March 1995 by M/s Godavari Fertilizers and Chemicals Limited. Thereafter, on 01.02.2008, Godavari Fertilizer was merged with the Coromandel Fertilizers Ltd. In the year 2009, company name changed from Coromandel Fertilizers Limited to Coromandel International Limited, however EC name could not be changed though CTO was changed and obtained on the name of the Coromandel International Limited, Kakinada and applied the name change of the EC as per the MoEF&CC office memorandum dated 3rd November 2023, Para 10 under the provision of EIA notification 2006."

7. As per para 11 of EIA Notification September 2006, a prior environmental clearance granted for a specific project or activity to an applicant may be transferred during its validity to another legal person entitled to undertake the project or activity on application by the transferor, or by the transferee with a written "no objection" by the transferor, to, and by the regulatory authority concerned, on the same terms and conditions under which the prior environmental clearance was initially granted, and for the same validity period.

## e-Pavments

8. Ch Srinivasa Rao working as Sr. Associate Vice President and Head Manufacturing at M/s Coromandel International Limited has signed the undertaking to comply the EC Conditions granted vide F. No. J- 11012/77/94-IA II dated 2nd March 1995. NOC signed by Sh. S. Sankarasubramanian working as Executive Director at Coromandel International Ltd. stating that Company name changed from M/s Godavari Fertilisers and Chemicals Ltd. to M/s Coromandel Fertilisers Ltd. in the year 2008. Later the name of the company changed from M/s Coromandel Fertilisers Ltd. to M/s Coromandel International Limited in the year 2009.

9. The documents have been uploaded by PP on PARIVESH portal viz. i) NOC from Transferor, ii) Undertaking from Transferee and (iii) Copy of Transfer of the firm from competent authority.

10. The CIN number of Godavari Fertilisers and Chemicals Ltd. - L24239AP1981PLC003325. The CIN number of

Coromandel International Limited is L24120AP1961PLC000892.

11. As per the relevant provisions of the EIA Notification, 2006, the Environmental clearance (EC) granted vide letter no. F. No. J- 11012/77/94-IA II dated 2nd March 1995 for Modernisation cum Expansion of the DAP Plant to Godavari Fertilisers and Chemicals Ltd. at Kakinada, Andhra Pradesh is hereby transferred from M/s Godavari Fertilisers and Chemicals Ltd to M/s Coromandel International Limited, on the same terms and conditions and validity period under which prior environmental clearance was initially granted.

12 . The MoEF&CC may revoke or suspend the clearance, if implementation of any of the EC conditions is not satisfactory. The MoEF&CC reserves the right to stipulate additional conditions, if found necessary.

13. The PP is under obligation to implement commitments made in the Environment Management Plan, which forms part of aforementioned EC.

14. This issues with approval of the competent authority.
