**MEMORANDUM OF ASSOCIATION**

**OF**

**COROMANDEL INTERNATIONAL LIMITED**

1. The name of the Company is "Coromandel International Limited".
2. The registered Office of the Company will be situated in the State of Andhra Pradesh.
3. The objects for which the Company is established are (and it is expressly declared that the several sub-clauses of this clause and all the powers thereof are to be cumulative and in no case is the generality of any one sub-clause to be narrowed or restricted by any particularity of any other sub-clause nor is general expression in any sub-clause to be narrowed or restricted by any particularity of expression in the same sub-clause or by the application of any rule of construction ejusdem generis or otherwise):-
  - (1) To manufacture, refine and prepare all classes and kinds of fertilisers and all classes and kinds of chemicals and industrial and other preparations arising from or required in the manufacture of any kind of fertilisers.
  - (2) To buy, sell, distribute and deal in India and elsewhere all classes and kinds of fertilisers and in all classes and kinds of chemicals and industrial and other preparations arising from or required in the manufacture of any kind of fertilisers.
  - (2A) To manufacture, refine, prepare, process, sell, export and generally deal in all types and varieties of cement (including coloured, white, fire, portland and alumina cement) and cement products.
  - (2B) To carry on the business of manufacturers, importers, exporters, agents, stockists, distributors, suppliers, refiners of, and dealers in, all kinds and forms of organic chemicals, heavy chemicals, graphite, carbon, petrochemicals, drugs, medicines, antibiotics, acids, alkalies, salts, cardials, fertilisers, insecticides, fungicides, weedicides, pesticides, detergents, pasting agents, solvents including industrial solvents, essences, pharmaceutical, medicinal, chemical and industrial preparations, mineral and other waters, natural and synthetic waxes, dyes, cosmetics, paints, pigments, oils, varnishes, resins and all products and by-products thereof, and to manufacture, process and deal in all or any other articles or things of a character similar or analogous to the foregoing or any of them or connected therewith.
  - (2C) To carry on the business of providing, directly or indirectly, management, technical, consultancy and/or advisory services of every kind and description in or outside India, and without limiting the generality of the foregoing, to act as agents for air, shipping lines, and to do or render such other services as are incidental thereto.
  - (2D) To carry on the business of manufacturers, processors, exporters and importers of and dealers in implements, accessories, plastics, polymers, reinforced plastics, resins, fibres of vegetable or synthetic origin, plasticizers, related chemicals and articles, materials used in micro irrigation systems, components and other applications in farm input related business.
  - (2E) To buy, sell, manufacture, refine, manipulate, import, export and deal in both wholesale and retail, agriculture and non agriculture related durable/non durable items of daily use, and to provide services in the field of insurance, banking and related areas.
  - (2F) Manufacture and or trade in Gypsum based building materials including value added load bearing panel, boards, plaster products, putties and related building material products and provide services in construction, erection/ installation of the panels/boards and engage in related construction activities.
- (3) In connection with the objects of the Company to irrigate, cultivate, improve and develop any lands whether belonging to the Company or not and to develop the resources thereof by fertilizing, clearing, draining, fencing, cultivating, planting, farming, letting or otherwise, with power to advance monies to other persons for any of the purposes aforesaid.
- (4) To take on lease, hire, purchase or acquire by licence or otherwise any lands, plantations, rights over or connected with lands, mills, factories, plant, buildings, works, shops, boats, barges, launches, cars, wagons,

carts, tractors, aeroplanes, machinery, apparatus, stock-in-trade, patents, inventions, trade marks, rights, privileges and moveable or immovable property of any description which may be deemed necessary or convenient for any business which the Company is authorized to carry on.

- (4A) Subject to the provisions of the Companies Act, 1956, or any statutory modifications or reenactment thereof for the time being in force, to amalgamate or to enter into partnership or into any arrangement for sharing profits, union of interests, co-operation, joint-venture or reciprocal concession with any person or persons or body corporate or bodies corporate carrying on or engaged in, or about to carry on or engage in, or being authorized to carry on or engage in any business or transaction which the Company is authorized to carry on or engage in or which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the Company.
- (5) To adopt such means of making known the products of the Company as may be deemed expedient, and in particular by advertising in the press, exhibitions, demonstrations and circulars and by granting prizes, rewards and donations.
- (6) To buy, sell, manufacture, refine, manipulate, import, export, and deal both wholesale and retail in commodities, substances, apparatus, articles and things of all kinds capable of being used or which can conveniently be dealt in by the Company in connection with any of its objects.
- (6A) To carry on business as Merchants, Traders, Dealers, Commission Agents, Clearing and Forwarding Agents, Buying and Selling Agents, Brokers, Importers and Exporters, and for that purpose to import and export, buy, sell, exchange or otherwise trade and deal in goods, produce, articles and merchandise of any kind whatsoever.
- (7) To construct, carry out, maintain, improve, manage, work, control and superintend any markets, reservoirs, water works, tanks, bridges and works in connection therewith, hydraulic works, electrical works and factories, employee lines and houses and bustees, villages and other works and conveniences, which may seem, directly or indirectly, conducive to any of the objects of the Company, and to contribute to, subsidise or otherwise aid or take part in any such operations.
- (8) To aid, pecuniarily or otherwise, any association, body or movement having for an object the solution, settlement, or surmounting of industrial or labour problems, or troubles or the promotion of industry or trade.
- (9) To expend money in experimenting on and testing and in improving or seeking to improve any patents, rights, inventions, discoveries, processes or information of the Company or which the Company may acquire or propose to acquire.
- (10) To apply for, purchase or otherwise acquire any patents, brevets d'invention, licences, concessions and the like conferring any exclusive or non-exclusive or limited right to use any secret or other information as to any invention which may seem capable of being used for any of the purposes of the Company or the acquisition of which may seem calculated directly or indirectly to benefit the Company and to use, exercise, develop or grant, licences in respect of or otherwise turn to account the property, rights or information so acquired.
- (11) To enter into any arrangements with any governments or authorities, supreme, municipal, local or otherwise, that may seem conducive to the Company's objects, or any of them, and to obtain from any such government or authority, any rights, privileges and concessions which the Company may think it desirable to obtain, and to carry out, exercise and comply with any such arrangements, rights, privileges and concessions.
- (12) To establish and support or aid in the establishment and support of associations, institutions, funds and trusts calculated to benefit employees or ex-employees (including Directors) of the Company or its predecessors in business or the dependents or connections of such persons, and to grant pensions and allowances, and to make payments towards insurance, and to subscribe or guarantee money for any national, charitable, political or benevolent objects, or for any exhibition, or for any public, general or useful object.
- (13) To construct, maintain, and alter any buildings or works necessary or convenient for the purposes of the Company.
- (14) To invest and deal with the monies and funds belonging to or entrusted to or borrowed by the Company in lands, buildings, bullion, commodities, articles, goods, negotiable instruments, loans, advances against property or goods, Government, municipal and other bonds, shares, stocks and securities, of any company whether constituted in India or in any foreign country, and in such other investments, and in such manner, as may from time to time be determined, and to vary such investments and transactions.

- (15) In connection with the objects of the Company to advance and lend money and assets of all kinds to such persons and on such terms and with or without security as may seem expedient, and in particular to customers and others having dealings with the Company, and to guarantee the performance of contracts by any such persons, provided that the Company shall not carry on the business of banking as defined by the Banking Companies Act.
- (16) To borrow or raise secure the payment of money in such manner as the Company shall think fit, and in particular by the issue of mortgages, bonds, debentures, or debenture-stock, perpetual or otherwise chartered upon all or any of the Company's property both present and future, including its uncalled capitals and to purchase, redeem, or pay off any such securities and to devote any money so raised to any of the objects of the Company.
- (17) To remunerate any person or company for services rendered, or to be rendered, in placing or assisting to place or guaranteeing the placing of any of the shares in the Company's capital or any debentures, debenture-stock or other securities of the Company, or in or about the conduct of its business.
- (18) To draw, make, accept, endorse, discount, execute and issue cheques, promissory notes, bills of lading, warrants, debentures and other negotiable or transferable instruments.
- (19) To guarantee the payment of money unsecured or secured by or payable under or in respect of promissory notes, bonds, debentures, debenture-stock, contracts, mortgages, charges, obligations, instruments and securities of any company or of any authority supreme, municipal, local or otherwise or of any persons whomsoever, whether incorporated or not incorporated, and generally to guarantee or become sureties for the performance of any contracts or obligations.
- (20) To sell or dispose of the undertaking of the Company or any part thereof for such consideration as the Company may think fit, and in particular for shares, debentures, or securities of any other company having objects altogether or in part similar to those of this Company.
- (21) To sell, manage, or dispose off, turn to account, of otherwise deal with, all or any part of the property and rights of the Company.
- (21A) To acquire, build, construct, install and operate roads, buildings, storage tanks, warehouses, and other infrastructural facilities of all kinds, in connection with its objects or otherwise, and to carry on the business of hiring, leasing or letting out the said roads, buildings, storage tanks, warehouses and facilities and equipments on hire, rental, leave or licence basis or otherwise, and dealing with all such assets including plant, machinery, equipment and facilities acquired, constructed or installed or to be acquired, constructed or installed and wherever situate.
- (21B) To provide services in the areas of farming/farm operations/related activities, veterinary services, owning and/or hiring/letting on hire farm implements/machineries, sub-letting of space in premises, servicing of farm implements/machineries, to provide services such as payment of electricity/telephone/taxes/revenue related bills, ticketing services, servicing of all electronic/white goods and such other items/products, provide medical services including tele-medicine and such other general services needed in daily life.
- (21C) To enter the field of education for providing school education, under graduation, post graduation, research programmes, higher education in academic, professional, technical courses including information technology both software and hardware, imparting of soft skills, spoken English, vocational courses and such other allied activities by promoting schools, colleges, polytechnics, coaching centres, educational institutions, tutorials and or any other form and to seek governmental/statutory approvals and to promote, aid and/or support through contributions/donations, trusts, societies, institutions and/or any other form of organization.
- (22) To distribute any of the property of the Company in specie among the members.
- (23) To procure this Company to be legalised, registered, domiciled or recognised in any foreign country, and to procure its incorporation in a like character, or as a Societe Anonyme in any foreign country.
- (24) To do all such things as are incidental or conducive to the attainment of the above objects.

AND IT IS HEREBY DECLARED that the word "Company" in this clause when not applied to this Company shall be deemed to include any partnership or other body of persons, whether incorporated or not incorporated, and whether domiciled in India or elsewhere.

4. The liability of the members is limited.

5. \*"The Authorised Share Capital of the Company is Rs.60,00,00,000 (Rupees Sixty Crore only) divided into 55,00,00,000 (Fifty five Crore) equity shares of Re.1/- each and 50,00,000 (Fifty Lakh) cumulative redeemable preference shares of Rs.10/- each, with such rights, privileges and conditions respectively attached thereto as may be from time to time conferred by the regulations of the Company; with power to increase and reduce the capital of the Company and to divide the shares in the capital for the time being into several classes and to attach thereto respectively such preferential, qualified or special rights, privileges or conditions as may be determined by or in accordance with the regulations of the Company and to vary, modify, or abrogate any such rights, privileges or conditions, in such manner as may for the time being be provided by the regulations of the Company."

We, the several persons whose names and addresses are subscribed, are desirous of being formed into a Company in pursuance of this Memorandum of Association, and we respectively agree to take the number of shares in the Capital of the Company, set opposite our respective names.
